## **TERMS AND CONDITIONS - DECLARATION BY ADOPTING PERSON**

I/We ..... agree to the conditions of adoption below and will comply with them at all times. I/we have absolutely no objections to periodic visits to my/our home by authorised representatives of Forget-Me-Not Animal Rescue (FMNAR). I/we understand FMNAR reserves the right to repossess the animal if they are not satisfied that he/she is being adequately cared for. The conditions are as follows:

### **ALL ANIMALS**

1. If at any time the above animal can no longer be kept, for whatever reason, he/she must be returned to FMNAR without delay. Arrangements for return may be made by telephone. The reasons for return are not important: the main thing is to return the animal.
2. The animal must not be put to sleep (unless on the advice of a veterinary surgeon because of serious illness or injury) or adopted to another person/family without the permission of FMNAR.
3. Proper arrangements must be made for the care of the animal in the event of the adopting persons absence due to holidays or illness.
4. Animals must NOT be used for breeding purposes.
5. The animal must be micro chipped where possible.
6. The animal is and remains the property of FMNAR for the rest of his/her life.
7. Change of address or telephone number to be notified to FMNAR.
8. FMNAR is not liable for future veterinary fees incurred in the treatment of the animal.

## RESTRICTIONS ON LIABILITY

1. FMNAR shall have no liability under this agreement:
  - (ii) for any disease, defect or illness, of any animal adopted by the adopting person.
  - (iii) for any loss, damage, expense or personal injury caused directly or indirectly by the animal adopted by the adopting person.
  - (iv) for any indirect or consequential loss resulting from the negligence or any other sort on the part of FMNAR or any of its officers or agents.
  - (v) for any future veterinary fees incurred by the adopting person in the treatment of the animal which is the subject of this adoption agreement, and/or the cost of treating any illness, disease or any condition, whether the same was incurred prior to the adoption agreement or subsequent to the date of the said agreement.
2. FMNAR does not permit the animal concerned to be adopted by the adopting person with any guarantee, warranty, condition or stipulation as to his/her health, quality, state, suitability or behavioural characteristics of the animal which is the subject of this adoption agreement.
3. Where the adopting person agrees to adopt the animal concerned it is hereby agreed to be accepted by the adopting person, upon the following further conditions:
  - (ii) that the adopting person has examined the animal prior to his/her confirmation and acceptance of this agreement of adoption and that the said animal which is the subject of the adoption shall be delivered to him/her in the same condition as at the date of such examination.
  - (iii) that the adopting person is satisfied with the condition, health, state, suitability and characteristics of the animal which is the subject of this adoption agreement.
